To begin the Parade, proceed to the staging area at the north end of the Grand Canal and fall into line in time to start by 6:00 PM. The Satellite Beach Patrol Boat will announce the start of the parade at 6:00 PM on VHF 71. The Satellite Beach Patrol Boat will lead the parade, followed by the Santa Claus boat, Story Time. Parade communications will be on VHF channel 71, and VHF channel 16 will be monitored.

The Parade route follows the Grand Canal SOUTHBOUND, circling Lake Shepherd CLOCKWISE. The Parade ends just north of the Mathers' Bridge in the Banana River. Participants are encouraged to: Obey all Rules of the Road; Maintain a safe distance between boats; Proceed in single file; and Maintain a speed of 4-5 mph, or as directed by the Patrol Boat. **SPRA ADVERTISERS:** We seek to promote our local businesses. **HIGHTOWER BEACH COVENANTS:** The public needs the Hightower Beach restrictive covenants to remain in place, along with the County's oversight to help ensure equal, public access to our oceanfront parks for all. The protections, found in the Interlocal Agreement that accompanied the 2012 deed, set a clear precedent, and should not be amended. State documents clarify that millions of grant dollars were dedicated to purchase the land, that the County's past involvement was crucial in that success, while park management agreements shall support conservation and equal access.

The covenants were designed to create oceanfront parks for the public, and the City became a caretaker of Hightower and Pelican park properties to provide public use without differentiation in fees or access. Hightower was deeded on a conditional basis, which ensured that listed public recreational and conservation components were part of the contractual covenants of this Interlocal Agreement with the County.





The same user-based fees can legally be charged to all park visitors, as nothing prohibits them charging equal fees. But, ad valorem taxes placed into a special fund category are not the same as user fees. In addition, any amendment change sets a dangerous precedent for other County contractual agreements, especially when such agreements are advantageous to the public, freely entered into, and do not negatively impact the parties involved. Changing even a single covenant opens the door to future, unpopular modifications.

**RESILIENT FLORIDA:** Senate Bill 1954 was signed into law in 2021. This legislation was designed to support a coordinated approach to develop resilience coalitions to promote Florida's coastal and island resiliency. Future projects can enhance protection of inland waterways, coastlines, conservation lands, and reefs, which serve as natural defenses. Evacuating the barrier island in a timely manner is a concern all along our Brevard County coastline. The Pineda and Eau Gallie Causeways near the South Patrick Shores area have been diagnosed with critical evacuation deficiency that can imperil safe evacuation. The county and local cities can cooperate to work toward mitigating impacts, although different jurisdictions will likely have differences in how they rank various impacts. Informed discussions can move a reasonable plan forward. Space Coast TPO has been crafting a Transportation Resiliency Master Plan to identify elements that impact resilience in our communities. Sound data fosters smarter decision-making, and linking land use and transportation is critical for a cohesive and workable plan of action.

**ST. JOHNS WATER DISTRICT & FLOODING:** The St. Johns District operates and maintains 12 major water control structures, three navigational locks, one pump station, and some 115 miles of flood control levees that are part of the District's and U.S. Army Corp of Engineers' federal flood protection. Some of the worst flooding in hurricanes can occur on the lagoon side of the barrier island, which is generally lower-lying. Although, most of the time, the lagoon's water level is driven by seasonal ocean levels, with rain accounting for about 10% of the variation. **SR 513 UPDATE:** SR 513 \$14M resurface/rehabilitation project is programmed for construction in FY 24/25 with upcoming public meetings addressing safety improvements during the design phase in FY 22/23. The public engagement component will work to program the project in line with the community's vision for SR 513. **SIDEWALKS** @ **SR 513 & SR A1A**: It is FDOT's decision as to who is responsible for repairs in their ROW along the SR 513 west side sidewalk that was damaged several months ago. However, safety repairs are critical for residents and children walking and biking to school, as well as in meeting ADA compliance. FDOT stated that their sidewalk maintenance contractor has been scheduled to repair sidewalk areas. In addition, SR A1A sidewalk improvements will accompany bus pads and are being designed as such. The





Space Coast TPO has been working with FDOT to pinpoint A1A sidewalk gaps identified in the Bike/Ped Master Plan. Currently the following sidewalk project in our area is in the works along SR A1A: From Shearwater Parkway to the Pineda, as the Design is funded for FY 22.

**BREVARD SPS REPAVING PLAN:** The Brevard County paving plan for South Patrick Shores in FY 22/23 will include resurfacing the balance of the county roads to the east of SR 513, including selected gutter and pipe repairs.

**MUCK DREDGING UPDATE:** The handling and disposal of dredged muck material must follow State of Florida rules for chemical constituents and thresholds. As per the Sediment Sampling Plan required by the FDEP Environmental Resource Permit, the County tests the dredged material in the geotubes before it is loaded on trucks and transported for final disposal. If test results from the geotubes exceed the industrial clean-up target level, then the approach allows for disposal of the dredged material at a Class I landfill. The current completion date for the north Grand Canal Project is September 2024.

The contractor will begin shutdown of dredging near the week of Thanksgiving just south of the Moorings area. State and Federal permits require a "manatee closure period" from December 1st to March 15th each year. During this period no in-water work may take place. Then the DMMA site will then be demobilized for the season.

FORMERLY USED DEFENSE SITES (FUDS) PROGRAM: The United States Army Corps of Engineers (USACE) asked for rights-of-entry from those within and adjacent to the 52-acre Off-Base Disposal Area in order to evaluate the extent of potential Navy-related impacts. About 50% of FUDS disposal site residents have submitted the forms. Army Corps posted a video explaining the Remedial Investigation/Feasibility Study process for the Off-Base Disposal Area and the future path forward. To date, nearly 7 million dollars has been allocated toward this project.

The November 9, 2022 drop-in meeting to discuss the Off-Base Disposal Area Remedial Investigation and the fieldwork approach was canceled due to Tropical Storm Nicole. It is still urged that residents who have not yet signed the rights-of-entry forms do so as soon as possible, as USACE cannot guarantee that after they start the fieldwork, that such property will be included in the investigation. USACE ensures residents that, it is the contractor's responsibility to leave the property in the same condition it was in prior to the contractor doing the investigation. # 45th Space Wing RESTORATION ADVISORY BOARD (RAB) by Rick Mariani

In FY22, a year of planning/preparing for upcoming work:

• Wrapped up an 8-year contract that covered management and cleanup at most of Patrick SFB sites. 16 separate sites at Patrick were cleaned up and closed out.

• Initiated a new 10-year (\$15M) contract to continue management and cleanup at existing sites across Patrick SFB. FY22 work focused on planning for many of these sites.





• Awarded a \$3.5M contract for Phase I Remedial Investigation of PFAS at sites impacted by Aqueous Film-Forming Foam (AFFF). This will evaluate the "nature and extent" of the related environmental impacts; the planning process is underway.

• Contract to perform "Preliminary Assessment" of potential environmental impacts from non-AFFF PFAS sources at Patrick SFB was awarded as part of a contract in late Sept. This contract includes installations across the country, so installations will be prioritized and work at Patrick may not begin immediately.

#### In FY23, the expectations are to:

• Initiate implementation of "Phase II" cleanup at Patrick SFB bulk fuel storage area. This work will be initiated once the construction of the new tanks is completed. The north portion of the fuel storage area was remediated prior to new tank construction in Phase I. Phase II will complete petroleum cleanup activities in the south portion of the fuel storage area.

• Implement final treatment efforts (likely an injection) at small petroleum site; a series of treatment efforts were previously undertaken, but more groundwater treatment is needed to fully remediate the site.

• Proceed with cleanup efforts at the former practice Grenade Range. The initial phase of this process will involve finalizing the Remedial Investigation and Feasibility Study, and preparing a "Record of Decision" to document the remedy. **MELBOURNE UTILITIES IMPROVEMENTS:** Updates for improvements in the South Patrick Shores area are as follows: The Pineda Water Main Extension Project is on schedule to be completed in January 2023. Those streets currently at the end of the water system with dead-end lines in our area require more flushing, especially if the demand in an area is low. Once Pineda Extension is completed, the water mains will be looped and will have an additional feed from the north, which will help. Replacement of the water mains in some locations are expected after the new year.

PROPERTY ASSESSMENTS SKYROCKETED: Property

assessments escalated this year for new home purchases and other properties. School district revenues increased substantially, as Florida Today reported that the Brevard School District budget increased nearly 17% over last fiscal year. Senator Mayfield reported that Florida has allocated additional millions of dollars toward teachers' salaries throughout the State's school districts. Even as the need for more affordable housing is discussed, residential renters have been especially hard hit with higher housing costs. If your property is a long-held homestead property, the maximum allowable annual total assessment increase is capped at 3% for the county, city, schools, and their accompanying taxing authorities. However, for non-homestead properties, there is no cap for school assessment increases provided.

**UNTAXED VACATION RENTALS:** AIRBNB, like other businesses who collect state taxes from clients, should be responsible to ensure that their clients who offer short term/vacation rentals online, are licensed to do business, and that they collect and remit tourist and sales taxes directly through AIRBNB. This would be done in sync with state statutes and local ordinances to ensure vacation rentals are legally permitted and paying their share of taxes. As it stands now, our governments are losing out on the 5% tourist tax and the 7% sales taxes which are not being collected. These funds could be used to salvage our estuary and fund other projects.

**HOME-BASED BUSINESSES:** The State law for homebased businesses takes precedence over local laws. In addition, the law includes criteria that home-based businesses must meet to operate in areas zoned for residential use. This law does not supersede local laws, ordinances, or regulations related to transient public lodging establishments (vacation rentals) that are not preempted under ch. 509, F.S.
